I agree to participate in the Kariba International Fishing Tournament at Charara. I understand that fishing and boating on Lake Kariba involve many inherent risks, including but not limited to:

- \* Risks associated with navigation or water travel, including weather, waves, changing water levels , shorelines , islands and other boats.
- \* Floating , Submerged and partially submerged hazards , including trees , stumps , rocks , sand banks , shallow water , nets , debris and other natural or man-made obstructions , whether known or unknown and whether visible or not visible from the surface .
- \* Risks of boat capsizing, sinking, or mechanical failure.
- \* Risks associated with fuel , fire , batteries , electrical systems , engines , propellers , fishing equipment and other equipment used during the Tournament .
- \* Encounters with dangerous wildlife (e.g., crocodiles, hippos, snakes).
- \* The negligence of other participants or officials.
- \* I understand that emergency assistance , rescue , evacuation and medical treatment may be delayed , unavailable or limited due to the location and conditions on Lake Kariba , and I accept the risks associated with any such delay or limitations .

I acknowledge that participation in the Tournament is at my own risk and that the organisers do not undertake responsibility for risks which are inherent in or ordinarily associated with fishing and boating on Lake Kariba and attending any events associated with the tournament.

In consideration of being allowed to participate, I hereby agree to:

1. Accept all risks of personal injury, property damage, or death.
2. To the fullest extent permitted by law, I waive, release and discharge the organisers from claims arising from my participation in the Tournament , including claims arising from the ordinary negligence of the organisers , their officials , agents or representatives .

3. I agree to Indemnify and Hold Harmless the Organisers , to the fullest extent permitted by law , against claims , demands , losses, damages , costs and expenses arising from or connected with my participation in the tournament , including claims brought by me or by any person claiming through me.
4. Abide by all the official Tournament Rules and Safety procedures.
5. Confirm I am physically fit to participate and that my vessel is seaworthy with all required safety equipment.
